C I R C U L A R

WHEREAS, the Coal based Rajghat Power House (RPH) on completion of its useful life of 25 years in 2015, was not operational since 01-01-2016. Further, due to stringent pollution norms for coal based power plant operation in Delhi issued by DPCC vide order No DPCC/WMC-II/Power Plants/2015/2456-2470 dated 31-12-2015 and Issuance of New Guidelines of CEA for old power plant operation vide circular No 226/TPP&D/CEA/201/803-810 dated 09-06-2017, further operation of this plant is not feasible.

AND WHEREAS, most of the employees of RPH have already been transferred / diverted to Other Plants of IPGCL – PPCL and Delhi Transco Ltd. The remaining employees of RPH shall also be transferred to other stations of IPGCL-PPCL and its Head Office. Hence, no category of workman/ employees on permanent roll shall be retrenched / terminated.

AND WHEREAS, as per section 25-O of the Industrial Disputes Act 1947, IPGCL has applied for permission to close down the Rajghat Power House on 16/12/2019 to Labour Commissioner of Govt. of NCT of Delhi in accordance with the Law.

AND WHEREAS, the Labour Deptt. of Govt. of NCT of Delhi vide letter dated 08.09.2021 has informed that the application dated 16.12.2019 of IPGCL have been concluded and closed in the light of section-25(0)(3) of the Industrial Dispute Act, 1947.

AND WHEREAS, the Hon'ble Lt. Governor has also accorded its approval for formal closure of Rajghat Power House vide diary no. 38927 dated 30.03.2022.

Accordingly, Rajghat Power House, a Unit of Indraprastha Power Generation Company Limited (IPGCL) 'Stands Closed' with immediate effect.

This issues with the approval of Hon'ble Lt. Governor of NCT of Delhi.
