CIRCULAR

Attention of all officers/ employees of category 'A', 'B', 'C' & 'D' posts in the INDRAPRASTHA POWER GENERATION COMPANY LTD. / PRAGATI POWER CORPORATION LTD. is invited to the provisions of Rule 18(1) (ii) & 18(4) of the CCS(Conduct) Rules, 1964, which are applicable to IPGCL/PPCL, according to which all the officers/employees holding posts in category 'A', 'B', 'C' & 'D' shall submit an Annual Return in the prescribed performa giving full particulars regarding the immovable property inherited by them or owned or acquired by them or held by them on lease or mortgage either in their own name or in the name of any members of their family or in the name of any other person.

Attention of all officers/employees of IPGCL/PPCL is also drawn to the provisions of Rule 18(4) of the CCS(Conduct) Rules, 1964 according to which the prescribed authority may, at any time, by general or specific order, require a Govt. servant to furnish within a period specified in order, a full and complete statement of such movable or immovable property held or acquired by them or on their behalf or by any member of their family as may be specified in the order. Such statement shall, if so required by the Govt. or by the Prescribed Authority, include the details of the means by which, or the source from which, property was acquired.

All officers/employees working in category 'A', 'B', 'C' & 'D' posts in IPGCL/PPCL are hereby called upon to submit their Annual Property Return giving full details as on 31st December 2018 latest by 31st January, 2019 positively, failing which such employees may render themselves liable for departmental action under the provisions of relevant conduct Rules. It is also informed that in view of the DoPTs guidelines issued vide OM dated 07.09.2011, non-submission of APR-2018 as on 31.12.2018 latest by 31.01.2019 would invite denial of Vigilance clearance to the officer/employees.

All the Sectional Heads/ Departmental heads/ HoDs are kindly requested to bring contents of this Circular to the notice of all concerned.

All the Officers/employees of IPGCL-PPCL of category 'A', 'B', 'C' & 'D' are informed that only diarized Annual Property Return shall be accepted in the office of Manager (HR DC, Rajghat Power House Office Complex, 1st Floor, HR Building, New Delhi-110002 with the proper acknowledgement of DC cell employees. **Non-diarized** Annual Property Return shall not be considered by Disciplinary Cell for Vigilance and DC clearance for any reason.

A specimen copy of the Performa to be filled by the officers/employees is appended overleaf for necessary action. Copies of this Performa may be given to the concerned officers/ employees to do the needful. In case of any difficulty, office of Manager (HR)DC, may be contacted during office hours for clarification.
