Sub:- Eligibility of divorced / widowed daughter for grant of family pension.

Sir,

Pension / family pension to DVB employees are being paid as per the provisions / guidelines of CCS (Pension) Rule 1972. The amendment / modifications effected in the various provisions for pensionary benefits from time to time by Govt. Of India is implemented only on adoption of the same by DESU / DVB.

Subsequent to unbundling and creation of DVB ETBF-2002 pension and other pensionary benefits are being disbursed as per the provisions / orders adopted and followed by DVB. The family pension eligibility condition has been further extended by Govt. Of India order dated 25.08.2004 by including divorced / widowed daughter eligible for family pension. The condition of age limit of 25years in the case of unmarried daughter has also been deleted. The above eligibility conditions is subject to the condition that income of the divorced / unmarried / widow daughter shall not exceed the amount of minimum family pension + DR and she should not have re-married. Copy of GOI orders are attached for ready reference.
