C I R C U L A R

Four empanelled hospitals/lab. have been enlisted for Executive Health Check-up for the year 2013-14 on credit basis. Other than these 04 nos. of enlisted hospitals/lab., the executives can also get their Executive Health Check-up done from any of the panel hospitals notified vide O.O. No. CMO/13-14/F-1/118 dtd. 27.06.2013, whether Non-NABH, NABH or Super Speciality Hospital as per their convenience, on cash-basis, however, only a fixed amount of Rs.2,500/- per executive shall be reimbursed and any amount over & above Rs.2,500/- spent by the executive shall be borne by the executive from his/her own pocket. For getting the EHC done, referral from the opted dispensary is not required. The executive shall be reimbursed an amount of Rs.2,500/- on submission of the receipt of the EHC along with photocopies of the reports of the specialists' examinations/investigations/tests to the Finance Deptt. without any verification from the opted dispensary or CMO office. Four panel hospitals/lab. enlisted for Executive Health Check-up on credit basis are as under:-

1. Metro Hospital & Heart Institute, X-1, Sector-12, L-94, Sector-11, Noida (a Super Specialty Hospital).
2. Metro Hospital & Cancer Institute, 21, Community Centre, Preet Vihar, Delhi-110092 (a NABH Hospital).
3. R.L.K.C. Hospital, Metro Heart Institute, Naraina Road (near Shadipur Metro Station) Pandav Nagar, New Delhi (a NABH Hospital).
4. Dr. P. Bhasin, Path Labs (P) Ltd., S-13, Greater Kailash, Part-I, New Delhi-110048 (NABL Lab. with facilities for required specialist).

All the Executives i.e. Assistant Managers & equivalent (who have attained the age of 45 yrs. as on 01.01.2013) and all other Executives of the rank of Dy. Managers & above, who want to get their Executive Health Check-up done from above mentioned 04 nos. of enlisted hospitals/lab., are requested to indicate their choice of hospital for health check-up in the prescribed proforma, attached herewith, and return the same to this office within 10 days, so that hospitals can be asked to prepare a schedule of Health Check-up and inform the Executives about the date & timings of their check-up on telephone one day in advance. It is also requested to indicate the mode of collection of Health Check-up reports i.e. either by post or to be collected from the hospital by the Executive in person. All the Departmental Heads are requested to bring the contents of this circular to the notice of all concerned.
